

# **BEST PRACTICES CONSTRUCTION**



**Partnering** – Improved communications and issue resolution. Strive for open and honest communications. Engage even if not part of formal contract requirements. Start early and include all levels of the project team. Escalation ladders are a best practice.

**Joint Risk Register** – Has become a standard contract requirement. Intent is to have entire project team (including Contractor) identifying and managing risks. This enhances the partnering effort and will provide benefits to both the Contractor and Government.

**Change Management** – Aim is for resolution of changes in 30 days for typical small actions. Communicate and prioritize if there are multiple. This will increase for more complex issues and is also based on submittal quality.

**Issue Resolution** – REAs and Claims only get more complicated and less clear with time. Elevate these EARLY which will greatly expedite decisions. We may disagree, but that is OK. Everyone knows where they stand.

**Promote Safety** – Manage safety and health requirements and risk. Complacency is our enemy!

# **BEST PRACTICES CONTRACTING**



### **Participate in Market Research and Outreach Events**

- Track SAM.gov (<a href="https://sam.gov/">https://sam.gov/</a>) and respond to sources sought notices for AK District USACE announcements use keyword "W911KB"
- Alaska District supports Industry and Government outreach events: AGC, SBA, PTAC and SAME

If you've never worked with the Alaska District before, consider – Subcontracting OR Partnership (JV, Mentor Protégé)

## Know the solicitation, Ask questions during solicitation process, Attend site visits

- Submit everything that is asked for
- Make it as simple for the Government to evaluate your proposal as you can

## Communicate freely to resolve issues at the lowest level at the time of their occurrence

#### **FY22 Lessons Learned**

- Register in SAM.gov under the Unique Entity Identifier (UEI) that you propose under (JV)
- Submission of proposal check math for rounding errors
- Respond to Sources Sought keep capabilities statement updated



- 3. APP: Appendix A (2014 ed.); Ch 2 Checklist (2023 ed.)


## Plan the Work / Work the Plan/ Tweak the Plan

- SOH management experience (5 yrs '14; 3 levels '23)
- 2) OSHA 30 hr. card
- 3) 8 hrs/year of continuous training; 24 hrs last 5 years
- 4) Walk the job site; ID and correct hazards

- 1. <u>Safety Meetings</u>: Daily toolbox, weekly, monthly
- **2. Incentivize workers to <u>report hazards</u>**Prevents having to report an accident.
