Pamphlet 600 posted with effective date of April 1, 2022

The AK-DOL Prevailing Wage [Pamphlet 600 - Laborer's and Mechanic Minimum Rates of Pay](#) was posted with the effective date of April 1st, 2022. In government contracting, a prevailing wage is defined as the hourly wage, usual benefits and overtime, paid to the majority of workers, laborers, and mechanics within a particular area. The "majority of workers" is usually the union wage. AGC negotiates collective bargaining agreements with six different Unions in the building trades. The collective bargaining agreements are negotiated in good faith as the wages and benefit increases benefit both non-union and union workers in the third largest industry in our State. AGC and the AK-DOL have a common goal, to put Alaskans to work. The prevailing wage rate was established to ensure that contractors have a level playing field when bidding on government projects and ensuring that construction workers are paid a fair wage when working on these projects. 10 Ways Organizations Make Attacks Easy

What do cybercriminals love? (Mostly themselves, but that is beside the point.) They love organizations that have unmitigated risks in their web applications and application program interfaces (APIs). With the entire world connected via the internet, the easiest and quickest way for threat actors to infiltrate your systems or steal customer data is through web applications. Basically, everything from the code used to build the application or the API used to connect things to configurations and authentications are fair game.

The areas most often targeted for attack can vary and may change frequently as cybercriminals invent newer and more stealthy ways to worm their way into systems.

Criminals are most likely to employ the following attack types in their bid to infiltrate systems or steal sensitive customer credentials:

- Client-side attacks (**data breaches and credential compromise**)
- Supply chain attacks (**JavaScript and software**)
- Vulnerable application attacks (**Unpatched bugs/vulnerabilities and legacy applications**)
- Automated attacks (**Bots and DDoS**)

PROJECT CHECKLIST

Dear Customer,

Our intent is to streamline the ability to dispose of project type waste for all customers quickly and efficiently. The Solid Waste Facility's (SWF) ADEC operating permit allows for the acceptance of regular municipal solid waste, construction & demolition debris, and asbestos containing materials. All waste needs to be free of hazardous materials and be safe for our operators to handle.

Common Hazardous Materials*:

- Asbestos Containing Materials (ACM or RACM)
- Contaminated or polluted soils
- Paints, solvents, or pesticides
- Lead-based paint
- Lead pipe and solder
- Fluorescent tubes and bulbs
- Mercury switches and thermostats
- Refrigerants from air conditioning units.
- PCB-containing transformers or light ballasts
- PCB-containing paint or caulking
- Radionuclide-containing smoke detectors and exit signs
