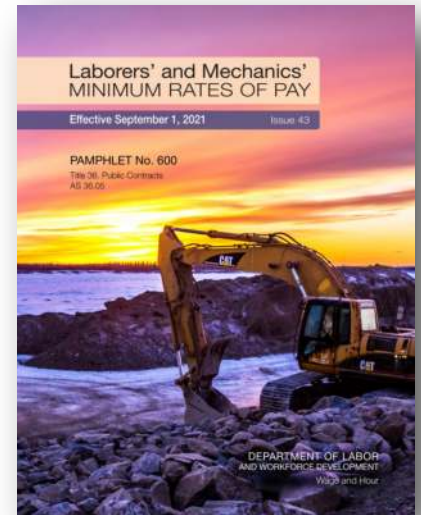
AGC of AK “Excellence in Safety” & “Excellence in Construction” Award Applications Now Online

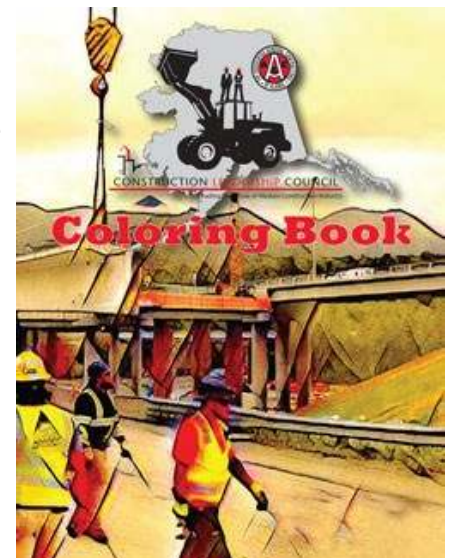
