This schedule is the baseline from which all progress is measured, provides the foundation for Pay Applications, and is the integration point with USACE's Resident Management System (RMS 3.0). COVID-19 Vaccine & Testing Updates

The staff at both the AGC of Alaska and the AGC of America (AGCA) are both hard at working monitoring the Vaccine & Testing & OSHA's draft emergency temporary standard. Below is some information, and several links for additional information and resources.

We will continue to send updates out as we receive them. Your membership dues to AGC, especially at a national level, are hard at work as we continue to push for guidance related to your projects and workforce.

On October 19 and 22, AGCA met with the White House Office of Management and Budget (OMB) to share a host of concerns about OSHA's draft emergency temporary standard (ETS). OSHA sent the draft ETS—the details of which remain unknown—to OMB for review on October 12, a signal that a final ETS could be issued within a matter of days or weeks. The OSHA ETS will require employers with 100 or more employees to ensure their workers are fully vaccinated against COVID-19 or tested for infection on at least a weekly basis.
